CHRISTIE'S

Hello all,

I've been engaged as a sort of 'consulting expert' to weigh in on this sale. I've long worked at the axis of the arts and fashion, and most recently have completed two exhaustive books on the subject of Supreme: *Art on Deck: An Exploration of Supreme Skateboards from 1998-2018*, and *Object Oriented: An Anthology of Supreme Accessories from 1994-2018*. The former released with Powerhouse Books November 19, 2019, and the latter with the same publisher January 20, 2020.

The books delve deeply into a few concepts that I find incredibly relevant to this culture, and also to this sale in particular. Much has been made of the 'hype' aspect of Supreme, and of this burgeoning new art-cum-investment category in general. This is entirely justifiable, and has had the added benefit of exacerbating prices very quickly, as though they were mid-17th century Dutch tulip bulbs.

The difference here, however, is that these objects are successful and sought over not because of some sort of 'roided out metastasization of hype, but because they are strongly articulated objects that present a cohesive vision, both culturally and societally.

Objects from Air Jordans to Off White x Rimowa suitcases are being rabidly collected as investment opportunities, but none more fervently than Supreme's output. Much as with the works of Pop Artists like Warhol and Lichtenstein in the 60s, displaying these objects in ones home provides not just an aesthetic impetus, but an totemic cultural one as well.

Supreme's objects (or accessories, if you prefer) represent a highly crafted collaborative vision of the broader culture, highlighting design icons not often thought of in the same scope as a Rietveld chair or a Poulsen lamp. A sort of quotidian alt-Design Museum. Like a Brillo Pad 'box', these objects are 3D pop art iconographs, imbued with the spirit of a Duchampsian readymade.

The skate decks, for their part, retain this spirit, but add a layer, in that they are physically emblazoned with the work from some of the last half century's most illustrious artists.

Supreme has always managed to meld a range of influences and signifiers, and the curation of their artist series of skateboards is very much in keeping with that. Neo-graffiti free thinkers like Rammellzee share the stage with larger-than-life juggernauts such as Damien Hirst and Takashi Murakami.

This show is a highly curated introduction to one of the world's fastest growing collector groups. The writing has long been on the wall, both physically and metaphorically. It's only going up from here.
